### IRS Lien Silver Bullet Packet - Strong Lawful Version

This packet is prepared for a living man or woman to rebut IRS lien fraud against private property. It includes a Cover Letter, Notice of Claim, Notice of Harm, Notice of Remedy, and a Declaration of Questions for the Record. All documents must be recorded with the Assembly and served by Registered Mail to establish lawful record and liability.

#### Service Instructions

- 1. Record packet in State/County Assembly record first.
- 2. Serve complete packet by Registered Mail with green card to:
  - IRS Commissioner and Regional Office
  - Secretary of Treasury
  - Court Clerk and Judge (if applicable)
  - Secretary of State (State)
  - Territorial Secretary of State
  - Attorney General
  - FBI RICO division
- 3. Keep copies, receipts, and tracking numbers.
- 4. If dishonored, issue Invoice #1, Invoice #2, then file commercial lien.
- 5. Escalate dishonor to international record: Hague, Lieber Code, Geneva Conventions.

### Declaration of Questions for the Record - IRS Lien

Questions placed into the record under penalty of perjury. Silence = confession.

- 1. Who are you, and under what lawful capacity do you claim to act against me, a living woman?
- 2. By what sovereign delegated authority do you act, and will you place into the record your oath of office and bond?
- 3. Do you claim we have a valid contract, knowingly, willingly, and intentionally entered with full disclosure?
- 4. Where is the original, wet-ink contract, signed knowingly, willingly, and intentionally by me?
- 5. Am I your slave, ward, or surety, and if so, produce the lawful document by which you enslave me?
- 6. On what lawful basis do you claim authority to seize, lien, or encumber my private property, absent a valid contract or judgment of a court of record of the people?
- 7. By your failure to prove jurisdiction, contract, or lawful authority, do you now admit liability for fraud, barratry, impersonation, and constructive treason, making you personally liable to me for harm, trespass, and damages?

#### Notice of Remedy - Rescission & Correction

- 1. The lien and related instruments are void ab initio for fraud, impersonation, and lack of contract.
- 2. Remedy is demanded: immediate rescission of lien(s) and correction of public record.
- 3. Dismissal with prejudice of any associated case or claim.
- 4. Acknowledgment of my status and standing as a living woman, not subject to U.S. codes.
- 5. Recognition that I am creditor, not debtor, and my property is private and exempt.

#### Notice of Harm - Erroneous Lien

- 1. I am a living woman, not a U.S. citizen, resident, or person subject to statutory jurisdiction.
- 2. The IRS has filed a lien against my private property, which is exempt and not subject to federal levy.
- 3. This action is based on fraud, as no lawful contract exists between me, the living [man/woman], and the IRS.
- 4. The harm includes intimidation, loss of peace, interference with right to travel, and commercial trespass.
- 5. I require immediate rescission of fraudulent liens and correction of the record nunc pro tune, ab initio.
- 6. Liability terms:
  - \$10,000,000 per unlawful act outside lawful delegation of authority.
  - \$1,000,000 per day for trespass, kidnapping, or unlawful detention.
  - \$100,000 per false presumption, misrepresentation, or unwarranted action.
