11. Explain to the fullest in your own words exactly what happened.

i, man, edmund clayton david of the sehring family was moving private property southbound on Country Club Road in the number 1 lane so i could make a u-turn. So i looked to make sure it was safe to make the turn, it was. I proceeded to make the turn into the middle northbound lane on Country Club road. there was no traffic in the left lane or the right lane. All of a sudden a car sped up behind me and blew the horn and then went around me to my left. I continued going northbound and started to merge into the right lane so i could make a right at the light, which i did. As i proceeded down the road i noticed lights flashing behind me so i pulled into the Flagstaff Mall parking lot near the Bank of America and turned off the truck. Ryan Smith approached the side of the truck that i was sitting in and i rolled down the window a little bit. He asked me for a driver's license which i replied i do not have and i proceeded to present him with my state national credential card which he responded by saying that it was not real. I told him that it was lawful identification. I told him that the truck i was moving in was not mine and handed him the registration. He went back to the car he was driving and came back about 10 min. later and said that everyone in ARIZONA needs to have a driver's license i told him i was not driving i was moving property, he said it was the law i said it is statute and code which are not law but are color of law. see attachment of continuation of section V.

So he came back to the truck I was in a short time later and asked me to step out of the truck which I complied with his request under duress. He then put my hands behind my back and hand cuffed me. I told him I had a pistol on my body. He said were, I said in the front of my waistband. He fumbled for a few minutes and finally removed it. I told him there was one in the chamber. He then proceeded to hand the pistol to Curtis Perry. He then proceeded to push me up against the cruiser he was driving in a rough manner. He then opened the door of the cruiser and he shoved me in. He then told me to sit back in the back seat so he could put seat belt on me. I told him I could not sit back because the cuffs were causing me a lot of pain, so he started to force me to sit back and I told him to stop. He then read me my supposed rights and asked me if I understood, which I answered no. He then proceeded to take me to Coconino County Jail and put me in a cage. The next day they asked me if I wanted to go to court, I replied yes, so they opened the cage and told me to get in the line for court, which I did, then they said I had to wear a mask, I responded that I did not have to and told them it was detrimental to my health. They said that if I did not wear the mask I had to go back into the cage. The same thing happened 2 more times a total of 3 days, so I was not allowed to be heard in the court. They kept asking me to let them take my finger prints, but I kept declining. I could not sleep because there was no mattress only a plastic tub, I have back and hip issue, so finally I told them if they let me go into general population I would let them finger print me. They then put me into solitary confinement for about three weeks because I would not let them give me the covid test. I was given the charges. I asked for paper and pencil to answer the court. They told me that I had to log into the commissary with the tablet they provided, but I had no money on the commissary to buy what I needed. So after a few days of asking and telling them over and over again that I had the right to answer the court and that they were interfering with that right they finally told me how I could get what I needed for free, so I received what I needed about 3 days later and answered the court. I was also given a court date but that date came and I was not taken to court. So after over days I finally was heard by the judge and he said he did not understand why I was still incarcerated. He then said that he was going to have me released in a couple of day. I spent 33 days in a cage for four misdemeanors that were all dropped on 2/1/2023.
