Declaration of Political Status, Re-Conveyance, and Revocation of Election

Preamble

I, Marianne Fidler(c), a living woman born on the land and soil of Arizona, one of the United States, do hereby publish, declare, and record the following facts for all to see, know, and take due notice of.

Numbered Declarations of Fact

1. I am a living woman, a creation of the Most High, permanently domiciled on the land and soil of Arizona, not a resident, subject, or employee of any foreign corporation.
2. I am not now and have never knowingly, willingly, or voluntarily acted as a "U.S. Citizen" (Territorial) or "citizen of the United States" (Municipal). Any presumption to the contrary is a mistake, fraud, or adhesion contract void ab initio.
3. I have revoked any election to pay federal income taxes, and I am prohibited by law from filing again once such election is revoked. (26 U.S.C. § 6013(g)(4)(A); 26 CFR 1.871-10; IRS Memo 4-4-1985).
4. I have recorded Assumed Name Certificates reclaiming all variations of my name and returning them to my living possession on the land and soil jurisdiction.
5. I have executed and recorded a Deed of Re-Conveyance, re-conveying my Trade Name, Marianne Fidler, back to my permanent domicile on the land and soil of Arizona, thereby correcting all records and returning myself to the jurisdiction of the people of my State.
6. I claim the protections of the Foreign Sovereign Immunities Act (FSIA), 28 U.S.C. §§ 1602-1611, as a foreign sovereign American relative to the United States corporations. I am not subject to foreign courts or codes absent my knowing, willing, and fully disclosed agreement.
7. In all dealings with the IRS, SSA, employers, banks, and other corporations, I stand as a non-taxpayer, non-citizen national, Arizonan, and private American. I am the paramount security interest holder in all assets registered and unregistered under my name.
8. For purposes of employment, I have provided lawful alternatives to the statutory W-4, including IRS Form W-8BEN, IRS Form 8233 (Modified), and an Affirmation of Status to Employer, which establish that I am not a "Withholding Agent" or federal employee.
9. My standing is further guaranteed by the Constitution for the united States of America (1789), the Constitution of the United States of America (1790), the Lieber Code of 1863 (General Orders 100), and the Hague Conventions of 1907.
10. Any presumption, contract, or registration to the contrary is hereby rebutted, rescinded, and nullified nunc pro tunc, nunc pro prae — I never lawfully left my land and soil jurisdiction. This record corrects all mistaken presumptions from the beginning of my life, applies now, and binds permanently into the future.

I declare under penalty of perjury under the laws of the United States of America, as they apply to the living people on the land and soil, that the foregoing is true, correct, and complete, without evasion, and that I have executed this Declaration knowingly, willingly, and without any mental reservation.
