## Notice to Principals is Notice to Agents, Notice to Agents is Notice to Principals

This Notice is to inform you that we, the living men and women of the Maricopa Assembly(c), as part of the Arizona Assembly(c) sent Notice of Ex parte Milligan with Notice of Intent - Fee Schedule to agents of the STATE OF ARIZONA/State of Arizona on July 30<sup>th</sup>, 2023, which was received by Governor Katie Hobbs and Secretary of State Adrian Fontes, and, by principals and agents doctrine was received by all agents of Maricopa County/MARICOPA COUNTY on August 2, 2023 by USPS Tracking numbers RF 388 087 546 US and RF 648 768 685 US. Your failure to recognize Ex parte Milligan by continuing to subject Americans to administrative, corporate and military tribunals under color of law,

after being Noticed that common law courts are operating on Arizona, is a direct violation of the Constitution(s). We have enclosed this Notice once again for your edification, as Katie Hobbs, Adrian Fontes and your predecessors are apparently inept or criminal.

The recent Supreme Court ruling SEC v. Jarskey, 603 U. S. 109 (2024) states, "it violates the Seventh Amendment for agencies to adjudicate common-law claims in their in-house courts. Agencies accordingly must repeal any regulation authorizing enforcement proceedings that enable the agency's courts to impose judgements or penalties that can only be obtained via jury trial in article III Courts." Administrative, corporate and military tribunals are not for People, they are for incorporated entities and persons, and forcing Americans into them while common law courts are operating, is a clear Constitutional violation.

American Common Law was declared the Law of the Land on October 5<sup>th</sup> of 2024 by the Federation – The United States of America, unincorporated, the only lawful government in this country. This means that our common law courts have Superior General Concurrent Jurisdiction. The Maricopa County Assembly(c) is up and running, as are the assemblies of every other county in Arizona, in addition to The Arizona Assembly(c). We are growing daily as people realize the crime and fraud meted upon them by corporations such as The Maricopa County Board of Supervisors (DUNS # 77535144).

The U.S. Supreme Court has ruled on several occasions that fraud vitiates everything. The most recent rulings are Hazel-Atlas Glass Co. v. Hartford-Empire Co., 322 U.S. 238 (1944), and Fedorenko v. United States, 449 U.S. 490 (1981). As everything that you and your corporations do is based on fraud, this puts you in a very precarious position. You are all personally and professionally liable for any harm caused by your actions, and we are holding you accountable.

You have now received Notice of Ex parte Milligan with Notice of Intent - Fee Schedule for the **second time**. From this day forward, you will be held personally and professionally liable for any harm inflicted upon Americans on Maricopa County per the enclosed Notice of Intent - Fee Schedule, including subjecting Americans on Maricopa County to the racketeering organization you call a "court system." We have also enclosed a Criminal Information, Claim and Notice of Liability to formally make you aware of the crimes you are committing against Americans on Maricopa County. Should you choose to continue to commit these crimes against any American on Maricopa County, you will be held personally and professionally liable by the Maricopa County Assembly(c).
