To all to whom these presents shall come:

- 1) Whereas: if the alleged incorporated States, per The Constitution for the united States of America Article I, § 10, Cl. 1, "...make any Thing but gold and silver Coin a Tender in Payment of Debts;" ; and
- 2) Therefore: are not the alleged incorporated States' and hence also the alleged incorporated United States of America's agents, hereinafter "Alleged Agents", operating outside any Sovereign delegation of authority upon the above Article I, § 10, Cl. 1 "State" land and soil jurisdictions; and
- 3) Therefore: why do I have any obligation to recognize any Alleged Agents; and
- 4) Therefore: would not any attempt to address me by any Alleged Agents be a criminal act per Cohens v. Virginia, 6 Wheat. 264, p 404 "to usurp... [jurisdiction] ... would be treason to the Constitution." and 18 USC 241, 242, 1341, 1962, 2381, 2382, ... ; and
- 5) Therefore: a) any future acts by Alleged Agents outside their delegation of authority will be deemed a mercenary crime, and Alleged Agents' agreement to this Criminal Information for Void Delegation of Authority and Notice of Liability, to the facts, law, notices, terms, and conditions herein, to my right to accelerate at will, and to a True Bill issued against all said Alleged Agents individually, per each occurrence, at ten million dollars (\$10,000,000) lawful money of The United States of America; and
b) Alleged Agents use of any form of my name other than above will be billed each as in a) above at one million dollars (\$1,000,000), as will be kidnapping per calendar day or part thereof; and
c) any other unwarranted actions, inactions, false statements or presumptions by Alleged Agents against me will be billed each as in a) above at one hundred thousand dollars (\$100,000) each; and

I, in my given name Tyrus Raymond Wynne III do as a man a North Carolinian from birth to now, declare under Penalty of Perjury under the Public Law of The United States of America unincorporated this Criminal Information for Void Delegation of Authority and Notice of Liability is true, complete, and correct to the best of my knowledge, with no intent to mislead, defraud, deceive, or threaten in any way, as my best effort, in "good faith and with clean hands," in common American English, in a lawful manner, not a legal manner, **and so require an answer in kind to 1) through 4) above, posthaste, to**
