

Arizona Public Law #1007 Prohibits the sale or auction of unclaimed property or assets

We, The Arizona Assembly(c), a member of The United States of America(c), unincorporated, with lawful superior concurrent general jurisdictions over land and soil, sea, and air in Arizona, hereby issue a Public Notice to all people, that it is declared and recorded by roll call vote, Arizona Public Law 1007.

Arizona Public Law 1007 demands that unclaimed assets, which includes land, houses, jewelry, money, digital currency, cryptocurrency, artwork, outstanding payroll checks, matured certificates of deposit, savings and checking accounts, uncashed dividends, securities and principal on debt, cashier's checks, money orders, security deposits, insurance proceeds, etc, be returned to the rightful owners or their families. If there are any owners known, they need to be contacted. There should be no auction of assets not belonging to the state or the Department of Revenue.

"The Unclaimed Property Law in Arizona was first enacted in 1954 to centralize the repository for lost property in Arizona. The law mandates that when firms fail to locate the owners of such assets within a specified time frame (usually one to three years), they must turn the property over to the Department of Revenue to safeguard these funds and assets. These assets are stored in a vault under the Department of Revenue Offices at 1600 West Monroe Avenue, Phoenix, Arizona 85007."

"Safe deposit box contents and safekeeping items are turned over to the State of Arizona three years after an owner stops paying rent. If the owner does not claim the items, the State must sell the contents at a public auction. All proceeds are placed in accounts for the owners of the property that has been sold. We do not auction land, vehicles or surplus property." (from www.azdor.gov).

Furthermore, all corporations and entities operating on our land and soil, are liable for any and all activities, and the consequences of those activities, that result in any physical, physiological, or psychological damage by depriving Americans of our right to bountiful health as given by our Creator.

We, the People of Arizona, are not subject to legislation passed by our employees for the purpose of regulating their own operations.

This is concurrent with Public Laws A1010121, A1010224 and A1010124 passed by all 50 states of The United States of America(c), unincorporated. These public laws apply to all Americans and U.S. Citizens in every state.
