## The Arizona Assembly(c)

## Rejection of all The World Health Organization, International Health Regulations, Pan American Health Organization and all subsidiaries

## Notice to Principal is Notice to Agent, Notice to Agent is Notice to Principal

Arizona is not a member of the World Health Organization/WHO or any related entities. Any presumption that Arizona State (unincorporated) has ever joined or been a member of the World Health Organization/WHO or any of its affiliate organizations, based on the membership of the United States of America (incorporated), are false.

This order is protected by the Federal Constitutions, Articles of Confederation, Treaties, Foreign Sovereignty Immunities Act, and Law of Peace. Any pandemic emergency, acts, declarations, statements or actions issued by the World Health Organization/WHO are not lawful on the land and soil of Arizona and are wholly rejected by the People/people on Arizona. Any and all infringements are considered acts of terrorism.

On behalf of The Arizona Assembly(c), I am writing to formally notify the World Health Organization/WHO of our Assembly's decision to reject membership and any obligations to the World Health Organization/WHO or its affiliate organizations. If you presume that we are or ever have been a member of the World Health Organization/WHO or any of its affiliate organizations, this is formal notification of withdrawal/rejection. We renounce the World Health Organization/WHO and all of its affiliate organizations. We reject any and all amendments, laws, regulations, statues, codes, mandates, and policy coming from the World Health Organization/WHO and any and all of its affiliate organizations.

As our American Government is a Living Government and its sovereignty is firmly vested in the living people of The United States of America (unincorporated) and exercised by the Lawful Persons of The United States of America (unincorporated), there can be no offer of contradictory authority from any foreign subcontractor nor any incorporated entity or agency working on a for-hire basis nor on a Voluntary basis nor acting upon Assumption of any prior contractual relationship. All foreign subcontractors (unincorporated, corporate, and/or incorporated) and all federal subcontractors (federal, territorial, and/or municipal), together with all franchises and agencies thereof, are obligated to stand subject to the authority of The Arizona Assembly(c) while proposing any action whatsoever in our behalf on Arizona.

Notice: Rejection of WHO



This Notice directs all World Health Organization/WHO enforcement agencies, agencies of the Federal government, check point administrators, Municipal and Territorial personnel and military personnel who have taken the oath to support and defend the Constitutions of the United States and the United States of America, to secure the natural and unalienable rights of all Americans on Arizona; additionally, hired contractors and other foreign agencies on Arizona are to heed this order. Any person inspecting living men or women (Americans) shall disclose their jurisdiction, bond information, identification, and are commanded to not detain, harass or hold the American.

All contracts, including tacit agreements, require informed consent of both parties. Anyone who interferes with our lawful activities and unalienable rights after having been served notice of these claims, and who fails to properly dispute or to make a lawful counter claim, is breaking the law. Please see the enclosed Notice of Intent - Fee Schedule regarding the cost for detaining, kidnapping, transporting, harassing or otherwise harming Americans on Arizona.

This Notice of rejection of the World Health Organization/WHO in all ways, shapes and forms is immediate in this notice of understanding, notice of intent, and notice of our claim of right. We require Written confirmation of your understanding that the People on Arizona and The Arizona Assembly(c) will not be subjected to World Health Organization/WHO resolutions, recommendations, or obligations. We require this written confirmation within thirty (30) days of receipt of this Notice. We also require that all data and records pertaining to The Arizona Assembly(c) or any of its members held by the World Health Organization/WHO be handled in accordance with international law and data protection standards.
