## **Az Jural Assembly Minutes 6.7.25**

The first meeting of the Arizona Jural Assembly was called to order at 8:02 am on June 7th of 2025 by court clerk Dave Sheldon.

**Attendees:** Cheryl, Dennis K., Dennis B., Karla Bell, Kristen Perkins, Steven Bell, Jeanie Watkins, Steven Hall, Marianne Fidler, Sharon Bell, Gaye Rutan, Stacy Mclaughlin, George Muisinga, Polly Merz, Bob Rogers, Gina Covel, Ani Plested, Nicole Sanders, Dave Sheldon

**Juror Duty** - Dave explained that ss a member of the Jury Pool and Jural Assembly, you accept duty as juror and state citizen, and you are automatically a jury member for your county. This is a very important task and you must be willing to accept the personal responsibility. We deal in nothing but facts in our Common Law courts, and facts can be presented in any way.

**Jural Assembly Affirmations:** Cheryl mentioned that affirmations are unnecessary for jurors. Dennis K. added that the Az Assembly is doing affirmations for elected positions this week. We will not be doing affirmations for our jurors, just for elected positions.

**Mission Statement** - We reviewed the mission statement of the Wisconsin Jural Assembly. Cheryl asked to email the statement out for review and discussion in our next mtg. Nicole shared a great comment regarding Common Law, Dave added it to the mission statement and is emailing it out to all for review and changes.

**Jury Nullification** - We have the power to nullify any laws that are repugnant. Our Jural Assembly Members can pass judgment on all acts of legislation affecting our States and People, including acts of any Federal Congress, any Territorial Congress, or any Municipal Congress that usurps upon our security or offers to disrespect our Natural and Unalienable Rights.

Gaye asked if this was applicable to our APLs as well, it is. However, jury nullification can only occur in a jury - that is, a claim must be before a jury in order for the jury to nullify a law.

Ani added that our Common Law jury has the right to question not only the facts of the claim, but the law as well. When our juries acquit a claimant or respondent who is factually guilty, they have nullified the law in question.

Dennis B. asked if we could do anything about our right to travel. Dennis K. shared that the de facto is entirely lawless at this point, but that we have passed an APL to address it and will continue liening them on this bill until they act appropriately. Dave added that we are working toward a more in-depth action regarding right to travel on the Notices Committee, targeting the AAMVA and ADOT (and others) with Notices soon.

**Justices Needed** - We just learned that every claim our courts adjudicate will require 3 Justices of the Peace - does anyone want to stand up and be a Justice? We need a minimum of 3 and maximum of 9.

Ani mentioned that she has sent her resume to Dennis K. for assembly consideration to be a Justice of the Peace. Steven Hall, a current Justice of the Peace on Pima County asked if he could put his hat on as a Justice for the state as well, Dennis K. added that he is currently a Justice fo the Peace as well. With these 3, we would have 5 Justices and will be capable of adjudicating any action before us.

**Other positions needed** - Bondsman, Court Recorder. Polly and Nicole mentioned that they have extensive experience as court reporters and would be willing to look into Court Recorder. Nicole has submitted her resume to Dennis K. for Az Assembly consideration for the position. As our courts get more active, this will be an important position.

**Jural Assembly Seal** - Dave asked if anyone wants to work on this. Ideally it would involve the land of Arizona - even merely an outline of the state, 2-3" x 2-3"

Dave is going to try to work up examples of a Jural Assembly seal/logo. Gaye worked up a great looking example, and Dave is going to send them all out to the Jural Assembly for review to vote on one in our next mtg. We need to work out the verbiage for this as well. Something with "Arizona Jural Assembly" at the top and something else on the bottom. We will work through this in our next mtg., after having some samples sent via email to review.

**Mock Trials** - Dave mentioned that he would like to put together a mock civil and mock criminal trial soon. The Jural Assembly responded affirmatively, and is ready to move forward and pursue mock trials of civil and criminal nature.

**Court Clerks / Justices meetings** - Dave shared that he will be interacting with court clerks on other states to share information, and that a similar committee will likely be created for Justices of the Peace soon.

**FL Document** - FL has put together a very nice 25-page run-down of the Jural Assembly, and we will be looking to tweak it and adopt it on Az. Dave mentioned that there are changes being made to this, and will email it out to the Jural Assembly for review as he gets the updated copy. The Assembly approved of the idea to adopt it, but needs to review it.

**Documents to study** - Declaration of Independence, NW Ordinance, Bill of Rights, enumerated services of Constitution, Educational Binder. Cheryl mentioned that the copy of 18 enumerated services that Dave had was done post-de facto, and she emailed Dave a better older copy that we can use. Dave is emailing these documents to the Jural Assembly for review. Nicole suggested we include the Magna Carta, great idea, and this will be included. Dennis K. added that these can be posted on our assembly website permanently for all to access.

**Ex parte Watkins** - The judgment of a court of record is final. This was a new one for Dave, he shared it with the Assembly, it came from the FL Jural Assembly document. Dennis K. affirmed that the decisions reached by our juries are FINAL.

**Standing Committees:** Litigation and Land Patent. Land Patent is dormant having reviewed the patent update process and landed on Anna's, on the website. Litigation is ongoing and kicking butt. Cheryl and Dave shared that the Land Patent Committee was tabled after concluding that Anna's process for updating the patent is solid. They shared that Anna has mentioned that a good task for the Land Patent committees on all states would be looking into land ownership of every square inch of our state. We like the idea of doing this.

Ani and Nicole mentioned that Litigation is busy looking into efficient methods of educating ASNs on the ins and outs of lawful and legal processes, terms, etc. They've done an amazing job and are always looking into new ways to protect Americans.

**Anything else?** Ani mentioned the nature of the phrase "I do not understand." When you say this, you refuse to contract - you refuse to "under stand" or "stand under" the de facto entity asking you if you understand. ALWAYS say, "I don't understand."
