Committee Reports

Notices Committee-Cheryl/Maricopa: They continue to send out notices to the bond companies and the judges and our elected officials. Hopefully when the liens take effect

we'll hear from them.

Constitution Committee-Shirley/Mohave: They are still working on it this

month so hopefully by October they will have it for us.

State Meet n Greet Committee-Diane/Yavapai: There is nothing to report until they get their votes in for the one of the two dates they gave us to choose from.

Litigation Committee: No Report

Outreach Committee-Diane/Maricopa: The committee meets at 4:30pm on September 21. Anyone is welcome to join that committee, she does ask that anyone who joins the committee makes a commitment to stick with it and not just pop in and out periodically.

All the committee meetings are listed on the website. They're working on breaking down the birth certificate document for easier understanding to those new to this topic. They will bring the document to the Assembly for approval and then they will be available to use for outreach. Woody/Maricopa states that he still has a PSA that he made a while back. He plays it for people he meets when he's out in public. He offers to send out a copy of it to anyone who wants it. He hasn't gotten it on public radio however. Dennis/Coconino suggests that he can get it on Yavapai Broadcasting which covers the entire state. In order for them to play the announcement, there has to be a public meeting associated with it, so if they can arrange a public presentation by the Assembly to run with announcement, they will play it for free.

Banking Committee-Cheryl-Maricopa: No meeting last week because of the holiday.

Their next meeting will be next Tuesday at 5pm.

Forms Committee-Diane/Maricopa: They will be meeting on September 14 at 2:30pm. The meetings are posted on the website, if you're interested in joining the Forms Committee all the info to get on the meeting are in the library. They use the MeetN platform so they can screen share. They took the forms that Dennis mentioned that are used in the De Facto system and modified them for Land and Soil. They are on the website in the Library for people to download and use. They are not putting the forms up for a vote unless someone has a complaint. They are currently working on a last will and testament. Gaye/Maricopa: She had to make a correction on one of the documents they listed last time, and the corrected form hasn't been re-uploaded to the website yet, but they will get it back up asap.

Coroners Committee-Cheryl/Maricopa: No report

Militia-Dennis/Coconino: They are having Militia meetings every Friday now at 6:30pm. They are brainstorming on how to stay alert and prepared and other miscellaneous helpful information.

Website Committee-John/Yavapai: In the Library, under "Welcome to the Library" on the far left side, there is the listing of all the different committee meetings, with phone numbers and contacts. They are also working on getting a calendar with similar information posted on the website. They are also uploading the replays and minutes from all the various committees and General Meetings on the public part of the website. So be aware that those recordings will be available to the public.

Vetting Committee-Dennis/Coconino: No Report. Angela/Pima asks if the Recording Secretaries are to reach out to the Vetting Committee for a questionnaire to give new members. Dennis/Coconino says that's to be done by the County Chair, the Vetting Committee is for people who are running for State Offices or for people who've been put on time out who are wanting to come back in.. Angela/Pima asks if there is a list of questions she should be asking before doing the recording ? Dennis/Coconino says he doesn't think that we do, Diane/Maricopa or Shirley/Mohave might have some questions they ask during the recording process. Other than that its through the Recorders, the County Chair or through your County Vetting Committee. Diane/Maricopa says the Recording Secretary Handbook is almost finished, there will be a list of questions included in the Handbook to ask them before you bring them in to paper them up. The Handbook is not to be used as a training manual to train Recording Secretaries, its only for Recording Secretaries that have already received their training as a reference guide. Diane/Maricopa says she's adding all the notes from all the questions she's asked Anna over the years.

Jural Assembly-Dave/Yavapai: We voted to approve the Primer as a working document moving forward. Gayle/Maricopa and Nicole/Maricopa worked up two new

mock trial scenarios. The first will be reviewed on September 20 at 8am. Gaye/Maricopa brought up the 1860's law that per Anna and the Jural Assembly Handbook, needs to be corrected by every State Jural Assembly. The Law states that only Caucasian land owning males can participate on the Jural Assemblies. Its a ridiculous law, I've been told not to worry about it, but I haven't seen any proof that it can be ignored. I don't want to move forward on a court case and then have the decision overturned down the road. We're looking to correct that, it should only take about five minutes. Dave is asking for 13 Caucasian males to step up on the next Jural Assembly call on

September 20 to vote that requirement out, that would be great.

Shirley/Mohave interjects that Anna did correct that in the Jural Assembly Handbook, we just need to find out where it is in the handbook to direct people there. Angela/Pima says if you go back to Anna's recordings, it was sometime in June 2022 when she addressed that issue.

Ombudsman Committee-Dave/Yavapai: They have a meeting on Friday at 5pm.

Dave asks about Frank's questions to Anna, an item that appeared on the Agenda and asks if he is supposed to address that. Dennis/Coconino says that was covered in the Q & A, but that Dave can discuss it if he wants to. He goes on to say that the only issue Frank addressed with Anna regarding the Ombudsman Committee was that she had made it very clear that the Ombudsman Committee needs to be a part of the process as soon as possible, so the sooner we can get a protocol committee meeting scheduled the better. Dave would like the chair of the Protocol Committee to know the he would like to be on that committee and would like to be notified of the next meeting. Dennis/Coconino gets more volunteers for the Protocol Committee.

International Business Committee-Cheryl/Maricopa: They continue to meet twice a month, Nothing particularly newsworthy to report at this time.

New Business

Dennis/Coconino: Announces the passing of our Head of State, James Belcher, for anyone who hadn't heard the sad news. We will be getting more information on a new Head of State as soon as Anna feels up to it. A card was sent to Anna on behalf of the Assembly offering our Condolences.

Shirley will forward an email of the card to Dennis so everyone can see it.

All meeting replay links are to be sent to Dennis/Coconino and John/Yavapai to be posted on the website so we have a record of all of our business.

State Meet n Greet-Dennis/Coconino: The meet n greet is going to be September 27 or October 11 at Pacific Seafood Buffet in Glendale, where we had it last fall. Everyone pick your preference of dates.

Voting Process motion from last meeting-Dennis/Coconino: See the current protocols, the voting is the same as its always been. Anna's talking about future voting where we'll have ballots and voting machines and all the election bells and whistles, but in the meantime we will be taking everyone's individual vote at the county level and then one vote per county to make it fair for the smaller counties. They will get the record of who voted yes, who voted no, and who abstained from the county chairs for their records.

Stephanie/Cochise asks about the County Chair for Cochise, because he is not active on the calls, and the last time we updated protocols we agreed that whoever was the County Chair had to be active, and if they missed more than a couple of months of the General Business Meetings, they could be replaced. Dennis asks if she is speaking of Miriam and Ed, she confirms, Dennis assures her that they are regularly in contact with him and that she can send her votes to them, or she can send her votes to him. She reminds him that we voted that the County chair could be replaced after two months.

She asks what the process would be for that. Shirley/Mohave says they have to vote the MIA County Chair out first and then nominate someone else.

Dennis tells her that they have to make sure that they notify all ASN's in their

county prior to taking any action.

Stephanie explains that she can't get the roster of members in her county because she can't get ahold of the County Chair. Angela/Pima suggests that Stephanie try emailing them one more time to express her concerns and also Cc Dennis on that email for accountability and hopefully she will get a response. She asks who's responsible for following up on these issues, Dennis says the people in the county. There is more discussion on this, Diane/Maricopa reminds Dennis that the protocol says if they miss four meetings, Dennis should call them. He tells the members in Cochise County to contact Ed since he's the actual chair and let him know if he doesn't start attending the meetings regularly, they will be looking for a new chair.

Deanie is not going to leave the Assembly in the lurch and she will continue to do the minutes until someone else expresses an interest.
